### Cost of living measure to support increased school running costs in 2024

#### 1. Introduction

- 1.1. The purpose of this circular is to set out the further arrangements in relation to the payment of the cost of living measure totalling €60 million to support increased school running costs announced as part of the cost of living measures in Budget 2024.
- 1.2. This grant is being paid to recognised Primary and Post Primary Schools in the Free Education Scheme which includes Voluntary Secondary Schools, Community and Comprehensive schools and to ETBs in respect of ETB schools.
- 1.3. The first instalment of this grant totalling €20 million issued to schools in October 2023.
- 1.4. The second instalment in respect of the remaining balance of €40 million will issue to schools shortly to assist with running costs in 2024.

#### 2. Purpose of Grant

- 2.1. The Department provides funding to all recognised schools in the free education scheme by way of per capita grants. The two main grants are the Capitation grant to cater for day to day running costs including heating, lighting etc. and the Ancillary grant to cater for the cost of employing ancillary services staff. These grants may be regarded as a common grant from which the Board of Management/ETB can allocate according to its own priorities. - 2.2. Additional funding has been provided as part of the Budget 2024 cost of living measures. This is to ensure financial supports are available for recognised primary and post-primary schools in the free education scheme to meet additional energy costs and other increased day to day running costs.

- 2.3. In relation to electricity and bulk heating fuels, schools and ETBs should be aware that centrally negotiated rates have been made available to schools/ETBs through frameworks sourced by the Office of Government Procurement (OGP). Information on how to avail of these arrangements is available via the Schools Procurement Unit website www.spu.ie or, in the case of ETBs by contacting procurement@etbi.ie.
- 2.4. In the context of the additional funding being made available to schools, it is expected that schools should not have to seek additional voluntary contributions from parents.

#### 3. Grant payment arrangements

- 3.1. This second instalment of the cost of living grant will be calculated based on recognised pupil enrolment at 30<sup>th</sup> September 2022. The grant paid to recognised Primary schools with an enrolment of equal to or less than 60 pupils is based on a minimum enrolment of 60 pupils.
- 3.2. Enhanced rates are payable in respect of pupils attending special schools and special classes and Traveller pupils attached to mainstream schools to assist with the extra costs associated with the running costs of classrooms with a small number of pupils operating specialist provision. These rates depend on the particular level of need involved.
- 3.3. The standard mainstream and the enhanced per capita rates payable in respect of the second instalment of the cost of living grant amounting to €40 million are set out in Appendix A below. The enhanced rates quoted are inclusive of the mainstream rate.
- 3.4. The standard mainstream and the enhanced per capita rates payable in respect of the full cost of living grant of €60 million are set out in Appendix B below. The enhanced rates quoted are inclusive of the mainstream rate.
- 3.5. Tables providing a sample of the level of funding available to schools of various sizes are also included at Appendices A and B.
- 3.6. The second instalment of this funding totaling €40 million will be issued to schools shortly. In the case of ETB schools, the second instalment of the cost of living grant will be paid to the relevant ETB.
